- Chest guard (hogu); Adults and Black Belts must wear a hogu that wraps around to the back
- Shin and instep protectors
- Forearm protectors
- Head gear
- Mouth guard
- Male competitors are required to wear groin protector

Board breaking competitors must supply their own boards for breaking.

1.
